### AMP Masterclass: Botched Blood Draws and Suppression

*Master how to win AMP suppression motions in all critical scenarios-when only the officer testifies, when the DA's phlebotomist takes the stand, and when a defense expert is called to challenge the blood draw evidence.*

The California DUI Lawyers Association presents the first exclusive, in-person masterclass on suppressing blood evidence in DUI cases-focused on Fourth Amendment violations due to failure to follow accepted medical practices. On February 20-21, 2026, at the California Desert Trial Academy College of Law in Indio, this elite day-and-a-half program will feature top defense attorneys who will reveal techniques that consistently deliver successful outcomes.

Participants will then put their knowledge to work in hands-on workshops, using their own cases. This unique combination of legal instruction, expert insight, courtroom simulation, and practical application makes this one of CDLA's most valuable and impactful programs – an essential event for lawyers dedicated to mastering AMP-based blood suppression litigation.

**Note: An essential part of this program is that each attendee bring a case to work on at the seminar. Attendees will be given the opportunity to review their case with the expert and instructors, and practice an AMP motion using their own case.**




