

He has also acted as a guest speaker at DRE training for law enforcement officers as a Forensic Specialist, and an adjunct professor teaching a toxicology course at Our Lady of the Lake Hospital in Baton Rouge for their forensic science program.

# 5.) SCAM ALERT! (New button/tab added to CDLA website)

After discussion at its 12/5/23 meeting, the CDLA Board of Directors agreed to create a new tab (or "button") on our website warning about scams and misleading/false claims made by firms like *Your DUI Solutions*:

#### **SCAM ALERT!**

CDLA members have received many complaints from clients that some companies are practicing law without a license and that the advice provided to prospective clients is misleading or wrong. These firms are very aggressive in soliciting clients. They often "promise" or "guarantee" a positive resolution of their DUI issue – for a fee, of course.

CDLA strongly recommends that clients file a complaint with both the Department of Insurance and the California Attorney General to report these unethical practices:

# 6.) MEMBER SPOTLIGHT: SUZANNE PERRY





I am the founder of Salient Analytical Services, and a 40+ year veteran of scientific spectrometry and analytical chemistry technology, providing analyses and meaningful data to clients in university, medical, and corporate scientific laboratories. I completed my B.Sc. (Hons) and M.Sc. (Hons) degrees in Gas Chromatography FID (HS GC FID) and GC–Mass Spectrometry (GCMS) in Biochemistry at Rutgers University and have advanced technical knowledge in enzyme-based immunoassays drug screens. In 1986, I was a scientist at Mycogen Corporation (now Dow AgroSciences) in San Diego, responsible for development of immunoassays and received two international patents for my work. I gained experiential knowledge in collection, handling, processing, instruments, and analysis of biological samples in clinical settings. This informed me of the critical gaps between hospital clinical screens and forensic analyses for the detection and quantitation of drugs and alcohol in biological specimens. At Mycogen, I also worked in microbiology and fermentation chemistry which foundations I bring to the courtroom in alcohol cases.

During my 24-year tenure at University of British Columbia, I developed the largest nonprofit mass spectrometry core facility in western Canada under the direction of 1993 Nobel Prize-winning chemist Dr. Michael Smith. My core facility was housed in 3 locations including the Centre for Blood Research. I taught analytical chemistry at both graduate and undergraduate levels. My lab's analyses are cited in over 60 peer-reviewed medical papers. I was a chromatography column consultant and distributor for polyLC INC (USA) for over eight years as well as a technology transfer consultant to ISO-accredited labs.

I began my work in Subject Matter Expert (SME) in Analytical Chemistry in 2014. In 2016, I studied at BCIT School of Nursing and obtained my Venipuncture Certificate in Phlebotomy. I routinely consult and testify on Approved Medical Practices (AMP) regarding forensic and hospital/clinical blood collection. My phlebotomy certification rounded out my ability to speak on "Draw to Data" issues in forensic toxicology analyses of alcohol and drugs. From 2016 to 2018, I was a Contract Faculty Member at Kwantlen Polytechnic University in Criminology and Criminal Justice. Here I honed my ability to speak of complex science topics and their intersection with the law with clarity and patience to provide the listener with agency in tackling these concepts.

I've lectured on the FDA 2019 recall of the grey cap tubes from Becton Dickenson and their impact on the reliability of the analytical results, as well as the current 2022 FDA Class 2 Recall of grey capped tubes off-gassing isobutylene into specimens. I am currently involved in statewide hearings in Washington regarding use of blood sampled from expired grey topped tubes. To date, 3 WA state counties have excluded data from blood obtained from expired tubes.

I have testified over 85 times across the USA and 3 Canadian provinces including more than 15 counties in CA in addition to over 125 APS hearings. I provide comprehensive reviews of the data in criminal and civil cases, as well as on behalf of public defenders since 2014. I've vetted data from forensic labs in 17 US states. My SME work encompasses review of DUI (alcohol/drugs), seized drugs, workplace drug testing and sobriety compliance testing, child custody cases, ante- and

postmortem analyses, hospital analyses, and personal injury cases. I also have been involved in solid drug analysis and clandestine laboratory cases.

I have enjoyed being invited lecturer and instructor for Continuing Legal Education for medico-legal topics combining science and the law to audiences including judges, prosecutors, law enforcement and attorneys over 23 times since 2016.

I offer every potential client a 30-minute free consult on your case. I maintain dual citizenship of US & Canada and can work legally in both countries. Based in Vancouver, BC, Canada, I maintain a home in Southern California and am located there 6 months/year.
