

4.) OPPOSITION TO AB366

The CDLA Board of Directors recently unanimously voted to **oppose AB366**, which would mandate the installation of ignition interlock devices (IIDs) for all individuals convicted of a first-time DUI offense in California, regardless of case-specific circumstances or the defendant's ability to pay.

AB366 recently passed the Assembly (unanimously!) and is now being considered by the Senate.

On behalf of the CDLA Board, ***I am requesting you contact your Senate representative*** to urge him/her to oppose AB366.

Jan has collaborated with legal and scientific professionals across Canada and the United States and served as the principal technical advisor to *The New York Times* for its year-long investigation into breath testing deficiencies. He has been featured by national newspapers, radio, and television outlets and is widely respected for his ability to translate complex science into accessible, courtroom-ready testimony.

As an educator and curriculum developer, Jan designs specialized training programs for lawyers, health and safety specialists, and forensic consultants. His teaching covers evidentiary breath testing, chemical exposure risk, workplace safety policies, and forensic reliability. He is also a sought-after speaker at regional, national, and international conferences on DUI investigations, occupational safety, and forensic best practices.

Jan is the editor and a frequent contributor to *Counterpoint – The Journal of Science and the Law*, a publication dedicated to exploring the intersection of scientific evidence and legal standards. He currently serves as Secretary of the *International Association of Forensic Toxicology Consultants* (IAFTC) and is an Associate Member of the *International Association of Chemical Testers* (IACT).

Through his work with the MyCAMprogram, Jan applies his forensic expertise to an urgent need: helping legal professionals and monitored individuals alike understand the risks, limitations, and issues surrounding *Continuous Alcohol Monitoring* programs.
