#### PRESENTER: MIKE DONALDSON



Mike was born and raised in Temecula. Back when it was still a small town with only a single stoplight. He watched the town grow on the backs of the hardworking men and women that moved here to raise their families. Mike's mother was a school teacher, and his father worked building fences across the Temecula Valley. Over the years, Mike saw many people, including close friends and family, land themselves on the wrong side of the law, mostly due to substance abuse issues. From the outside looking in, the criminal justice system never seemed like it fairly or adequately helped people who Mike knew deep down were good people, but were just struggling. The government never seemed like it wanted to do anything other

than put its boot on people's necks. Once Mike got his first experience in criminal defense, it felt like the perfect fit for somebody like him with a competitive sports background, and a desire to see people treated fairly.

Mike received an undergraduate degree from the University of California, Santa Cruz, and law degree at Santa Clara University School of Law. Throughout law school, Mike worked for the Santa Clara County Public Defender's Office defending people charged with misdemeanors and felonies. After law school, Mike worked at the Merced County Public Defender's Office.

Mike came back home in 2015, and started a criminal defense practice. He later joined a small but nationally recognized DUI defense firm in Riverside, CA called Bartell, Hensel & Gressley. There, Mike got to practice with Don Bartell, perhaps the best DUI attorney California has ever had. Don passed away unexpectedly in 2022, but his spirit lives on. After Don's passing, Lara Gressley and Mike decided to continue to carry the torch forward and started Gressley & Donaldson. Lara is one of the best DUI and appellate lawyers in the state.

Mike is a graduate of Gerry Spence's Trial Lawyer's College (now Gerry Spence Method), a contributing author to DUI defense practice guides, a member of the California DUI Lawyers Association, the National College for DUI Defense, and has lectured lawyers across California on issues related to DUI defense. Mike is the past-president of the Southwest Riverside County Bar Association, and a part-time professor of Political Science at Mt. San Jacinto College.

### 8.) MEMBER SPOTLIGHT: ANN GOTTESMAN



Ann Gottesman was raised in Huntington, New York with her younger brother. Her father worked as a physicist for Northrup Grumman and her mother was a Hebrew teacher. She was raised in a secular Jewish home. Science, history, literature and social issues were often the topics of conversation around the dinner table.

After graduating with a B.A. in Psychology from Cal State Los Angeles, Ann attended Southwestern University School of Law in Los Angeles, where she graduated three years later with a Juris Doctor degree in 2005.

Ann had always known that criminal defense was the area of law that would be most rewarding for her. For the past 17+ years, her legal pursuits have been focused on the practice area of criminal law with a special interest in DUI defense.

While in law school, Ann clerked for Justice Earl Johnson, Jr. of the Second District Court of Appeal. She assisted Justice Johnson with the drafting of judicial opinions, one of which was published as a case of first impression. (People v. Russell (2005) 129 Cal.App.4th 776.)

In 2005 and 2006, Ann worked for Marilee Marshall & Associates, a Los Angeles Criminal Defense firm specializing in criminal appellate law. She then became an associate for the Law Office of Michael Cabrera, where she represented clients in criminal and immigration cases.

She then joined the Law Office of the Public Defender in Riverside, California, because she wanted to help ensure indigent defendants received a fair trial. While a Public Defender, Ann Gottesman has passionately represented clients in trial and preliminary hearings. Since 2009, Ann has been practicing in Pasadena, California as a sole practitioner focusing solely on DUI defense and Criminal defense, handling misdemeanor and felony cases in the Los Angeles County courts.

One of the reasons Ann finds criminal defense so rewarding is because she sees how seemingly limitless the government's power is when focused on an accused. Without dedicated defense lawyers, the government is free to strip people of their freedom, reputation and future. Holding the government to their burden and ensuring an accused gets all the protections the Constitution promises is critical to keeping the government from overreaching.

Ann lives in Los Angeles with her husband Mark, their 14 month old son Akiva and their elderly dog.
