

PRESENTER: Chuck Sevilla



After receiving his law degree from the University of Santa Clara, Chuck Sevilla earned a master's degree (LL.M) from the Urban Law Institute at George Washington University Law School. He spent two years as an attorney in Washington, D.C., for VISTA, Volunteers in Service to America, before moving to San Diego to serve as a Federal Public Defender. Chuck rose to the position of Chief Trial Attorney in the San Diego Federal Public Defender office. In 1976, he was recruited to establish and head the Los Angeles office of the California State Public Defender office. Later he became the Chief Deputy State Public Defender for the State of California. In 1983, he and longtime friend and colleague, John Cleary, established the law firm of Cleary and Sevilla. In 2004, John Cleary retired from the practice to teach at Moscow State University in Russia under the auspices of the Fulbright Program, the U.S. government's flagship program in international educational exchange. Chuck continues his full-time criminal defense practice.

Chuck has argued cases at all appellate levels, including several times before the U.S. Supreme Court. He is a frequent speaker and presenter at legal conferences. Chuck has

published books on legal humor and three novels about a fictional New York City defense lawyer, John Wilkes. He has authored numerous law review articles and is the co-editor of a legal text, <u>California Criminal Defense Practice</u>, used by lawyers and in law schools throughout the country.

# 3.) NOMINATIONS FOR BOARD OF DIRECTORS

As per CDLA's Bylaws, nominees to be placed on an election ballot to serve a 4-year term on the Board of Directors can come from two sources: from the Board of Directors itself & from the membership.

If you are interested in serving on the CDLA Board of Directors for a 4-year term (from August 2025 to August 2029) - or would like to nominate another CDLA member to serve - the following is the *member nomination process* that must be followed:

- The nominee must provide endorsements from at least twenty (20) CDLA voting members using the CDLA nomination form or a letter of endorsement bearing the nominator's signature and bar number. (Please contact me to obtain a copy of the Nomination Form.)
- Endorsers need to send their letters of endorsement or nomination form directly to the nominee.
- Once the nominee has received 20+ letters/nomination forms, he/she needs to email the package of letters/forms to CDLA Executive Director Dr. Roger C. Andersen (ed@californiaduilawyers.org)
- The hard/firm deadline for receipt of all 20+ endorsements is Friday, May 9, 2025.
- After verifying the 20+ endorsements, Dr. Andersen will notify the nominee that his/her name will be placed on the election ballot.
- Each nominee will be requested but not required to provide a head-shot photo and a short bio, including the reason(s) for his/her candidacy which will be included with the election ballot.
- As per our bylaws, all nominees will be accorded "a reasonable opportunity...to solicit votes and a reasonable opportunity for all members to choose among the nominees."
- Nominees are authorized to use CDLA's listserv for this purpose.
- The results of the election will be shared with all members in July.
- Terms for newly elected Directors will begin following CDLA's annual conference this August.
- Information about the role, meeting schedule, and responsibilities for serving as a CDLA Director is included below


