



# 7.) MEMBER SPOTLIGHT: DAVID FOOS



David was raised in Pittsburgh, PA. His parents were very active in the civil rights movement and several social service organizations. When David was in high school, his family moved to the West Coast. David attended U.C. Berkeley where he majored in politics and sociology and was active in the anti-Vietnam War movement. David was fortunate enough to travel internationally while in college, and spend a year studying in Paris.

David attended San Francisco College of the Law and his first jobs out of law school were working in several Legal Aid Societies, providing representation in civil and administrative matters to the indigent. David continued to travel internationally and picked up a working knowledge of Spanish.

David next obtained employment with the Solano County Public Defender's Office, and worked for 8 years as a Deputy Public Defender in Solano and Sacramento Counties. As a public defender David handled primarily juvenile and felonies, and spent a couple of years defending DUIs and other misdemeanor matters. As a P.D. David handled many bench and jury trials.

In 1990 David was appointed by the Sacramento Bench as a Court Commissioner. As a Commissioner David handled Traffic infractions and misdemeanors, unlawful detainers, Small Claims, DUIs and other misdemeanors. David was active in the Court Commissioners' Association, and helped organized and taught at several workshops regarding traffic adjudication. David also served 3 years on the Judicial Council Traffic Adjudication Committee.

After 16 years on the Bench, in 2006, David shifted into private practice. For the last 10 years David has run a law firm, where he has 2 associate attorneys and a staff of 8. The practice is almost exclusively criminal defense, with some restraining orders, and a handful of civil matters. Of the criminal matters the firm handles quite a few DUIs. The firms' practice covers Sacramento and about 10 surrounding counties.

David has two grown boys, both scientists, and his wife, Dr. Susana Russ, who is a supervising licensed clinical social worker at a non-profit, and has a small private practice.

David also has a sweet dog – a pit mix named Maggie, who loves to wrestle at the dog park. For hobbies, David is very interested in politics, and travels as much as possible. Also, David and Susana have a small condo in the mountains, and spend many week-ends there, in the Tahoe area.
